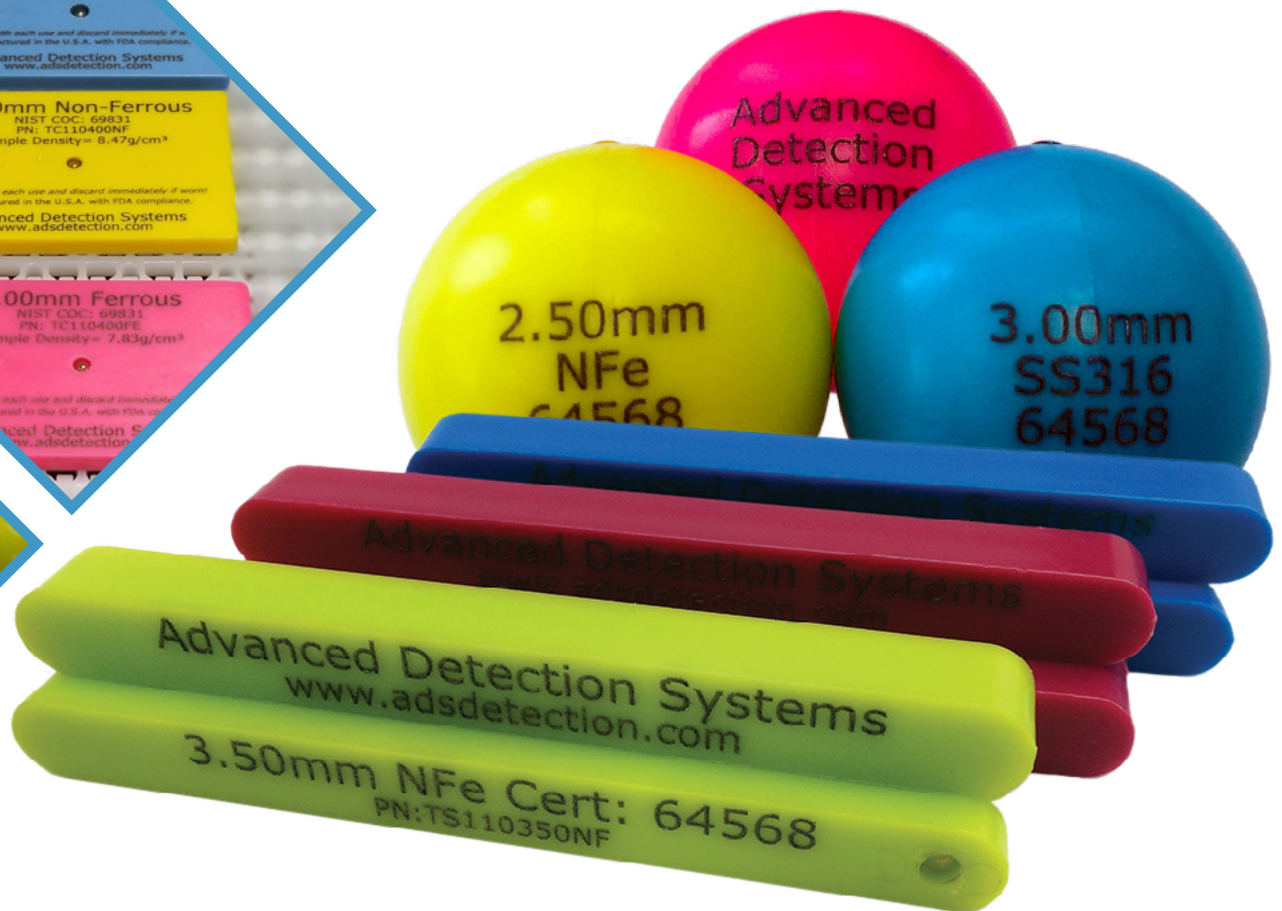

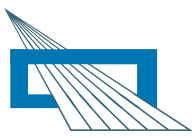

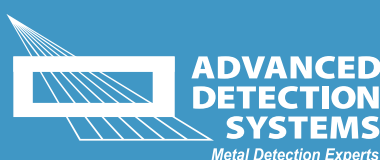
ProScan Pipeline System
